- **City**: Sarah Lim shared that the City has a plan to issue Homeless Services and housing resources RFP, within the next 1-2 weeks. City's budget process is kicking off in June, listening sessions will be available and posted soon
- County: JHotels to Housing Final report being reviewed for release Q2, Shelter and permanent housing RFP's will be released within the next 2 months, EDDP Extension approved (funding ends 09/30/25), Doubled Up Pilot Program is no longer accepting referrals (funding ends on 9/30/2025), HUD CoC Rental Assistance Contract started 04/01/25, Farmer Workers Housing In contract negotiations with a consultant, nINA Collective, Fair Chance Housing Provider selected (EXPO) and approved, AHDF- For a list of all housing developments visit: <a href="https://link.edgepilot.com/s/989d9133/FNEx0ip3fkq8bP1B-4ILNw?u=https://dcdhs.com/haa/hd">https://link.edgepilot.com/s/989d9133/FNEx0ip3fkq8bP1B-4ILNw?u=https://dcdhs.com/haa/hd</a>, CDBG/HOME/TBRA RFPs approved; waiting on notice from federal government.
- United Way: Angela Jones Shared Power Point on Agency Executive Director Convening, regarding concerns
  over current programming cuts from Federal Administration. Discussing DEI language with other funding
  sources, looking to collab with other agencies on how to handle current funding/HUD/Federal climate.

- Youth Action Board YHDP have seen a lot of resistance and barriers to obtaining transitional housing, YAB had
  an Open House for Youth Drop-In Center and community mixer, they're hoping for better attendance at future
