# American Rescue Plan (ARP) funded programs wind down timeline

- Doubled-Up Housing Pilot Funding through 09/30/25 (per federal regulations)
- Eviction Defense and Diversion Program (EDDP) Funding currently through 12/31/24;
   Legislation routing to extend contract through 09/30/25.
- Isolation and Quarantine Center Hotel Program ended 04/30/23
- Dane CORE-Portal for new applications closed 05/31/23
- Emergency Rental Assistance Security deposit program ended 12/31/23
- Hotels to Housing Program ended 10/31/24
- Outreach Services through Catalyst for Change Program ended 12/31/24

United Way: Preparing for the mid-reports due July 15<sup>th</sup>, landlord property management – mitigation funds and Governor's budget Milwaukee, LaCrosse and Green Bay shared how they are using funds, for example property damage and what it could look at for our community. (\$2 million for the entire state) Lived Experience Council: scheduled to watch Mike Bashford on Governor's proposal Youth Action Board: YHDP evaluating their program guide and policies way to improve or adjust by asking participants, YAB leading in evaluations, looking for community engagement had a coffee mixer and another event planned for April 12<sup>th</sup>

- Discussion & Action Item (continued from March meeting): Federal Funding Updates & Discussion of Implications

- COC projects, HUD started to release grant agreements then rescinded them and then reissued with new language, can't use money to pay for abortions, promote gender ideology, how to report abuse, only sent grant agreements for the first part of the year, our community will have one next in July 2025, must use a federally approved database for immigration status, it is unknown what databases they are as they have not been shared
- This is a way to cut and slash so it doesn't matter as long as what we decide is something we can live with, there is Confusion & Chaos leading to fear, harmful loss of funding, fair housing contracts have been temporary funding has been restored, then another issue is new funding, new language has been focusing on immigration and gender, antidiscrimination laws – who are programs targeting
- o **Action:** Determine HSC's response to federal landscape. Options:
  - No change, the administration's values have changed but ours haven't
    - Like 1 Live 10 Uncertain 1 Uncomfortable 2
  - Begin an effort to change language simply with a review of the current language so that we are less likely to experience consequences that impact our work

Form a work group that will identify and review language in public facing documents owned by the CoC to determine where changes may be required and report back to the HSC Board of Directors.

Form a workgroup to create a list of documents, identify those that have language that may be flagged, and report back to the Board. Likes 14 Live 0 Uncertain 0 Uncomfortable 0

- Remove things that may flag us, and add them back once language is changed Like 0 Live 1 Uncertain 0 Uncomfortable 12
- Presentation & Action Item: Info on Embolden, potential fiscal sponsor Chara Taylor
  - Potential fiscal sponsor
  - o **Action:** Determine how to move forward with Embolden.
  - Likes 14 passes unanimously
